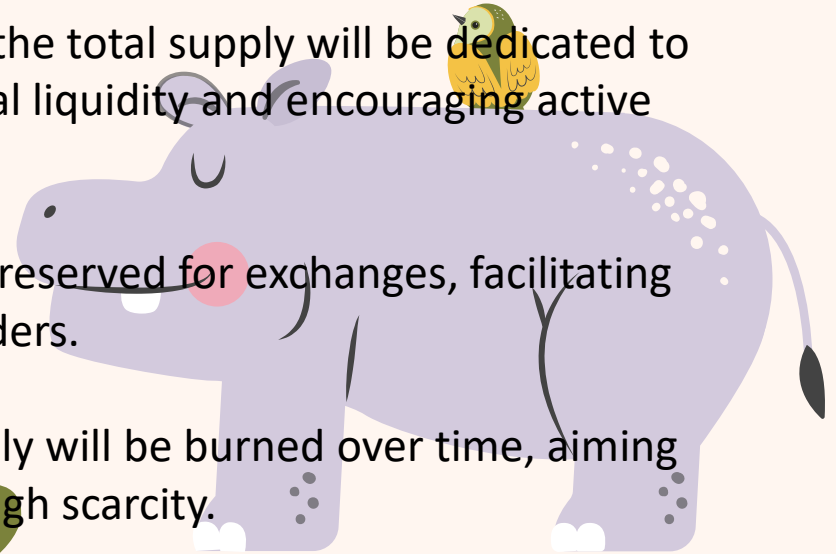

- **Smart Contract Audits:** Thorough audits by reputable firms to identify and mitigate potential vulnerabilities in our smart contracts.

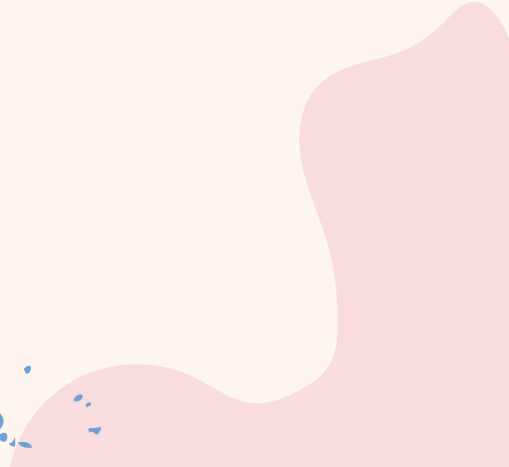
- **Burn Strategy:** The burn strategy ensures a gradual decrease in supply, minimizing the potential for sudden price fluctuations.

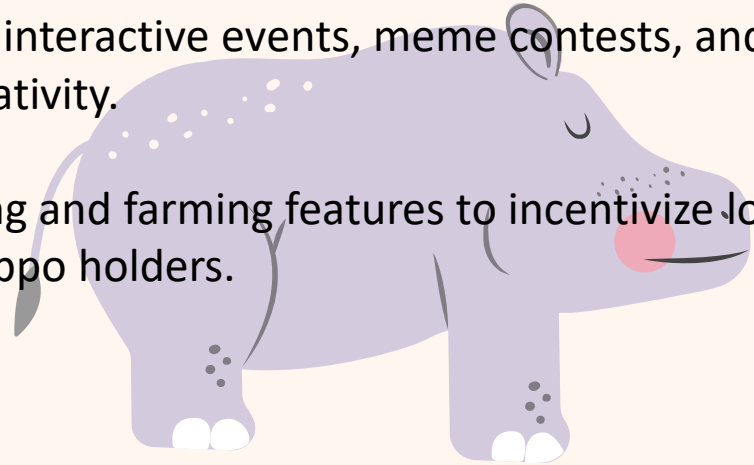
Phase 4 - Pancakeswap Listing and Outreach (Q4 2023)

- **Community Incentives:** Rewarding early supporters with special benefits, promotions, and exclusive Crazy Hippo NFTs.



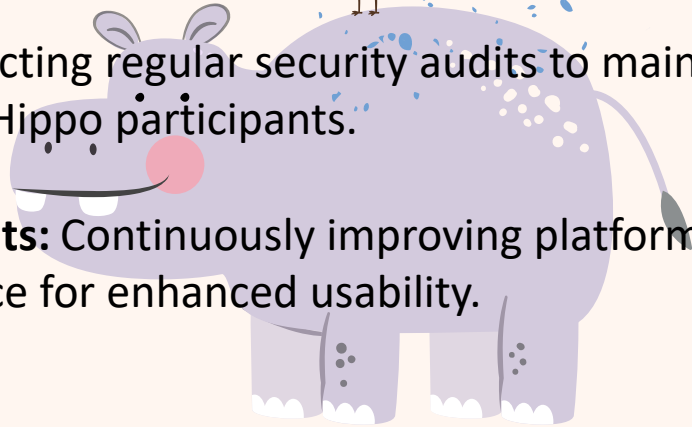
Phase 5 - Community Engagement and Expansion (2024)
